**AN ORDINANCE AMENDING ORDINANCE NO. 10-2010 AS
AMENDED BY ORDINANCE NO. 10-2011, AS AMENDED BY
ORDINANCE NO. 5-2012, AS AMENDED BY ORDINANCE 5-2018,
AS AMENDED BY ORDINANCE 9-2020, AMENDED BY
ORDINANCE NO. 10-2020, AND AS AMENDED BY ORDINANCE
NO. 12-2020**

WHEREAS, the Board of Commissioners of the City of Winchester, Kentucky deems it advisable to amend Ordinance No. 10-2010, et.al.; and

WHEREAS, the Board of Commissioners has determined that Section 2-386 Compensation of Members needs to be amended to show the adjustment in the stipend received by board members; and

WHEREAS, the Board of Commissioners has determined that Section 2-395 needs to be amended to show the new KRS Statutes regarding Lien; fines, charges, and fees inside the city limits.

NOW, THEREFORE, BE IT ORDAINED BY THE City Commission of the City of Winchester, Kentucky as follows:

SECTION I. Section 2-386 Compensation of members.

For each official Board meeting attended, each Board member shall be paid a sum of ~~Fifty~~ one hundred dollars (~~\$50.00~~ 100.00)

SECTION II. Section 2-395 Lien; fines, charges, and fees.

(c) Pursuant to KRS 65.8835, the lien shall take precedence over all other liens on the property, except state, county, school board, and city taxes, and may be enforced by judicial proceedings or to the extent permitted by law administrative hearing board enforcement proceedings.

(1) Pursuant to KRS 65.8834 the City may include the amount of any unpaid lien that has been recorded pursuant to KRS 65.8835 on any property tax bill that the City collects.

(2) In addition to the enforcement procedures authorized by KRS 65.8835, the City may enforce uncollected liens arising pursuant to KRS 65.8835 in the same manner as authorized for unpaid tax bills.

SECTION III. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

SECTION IV. All portions of this ordinance amending the Code designate words and figures which are deleted by including such words and figures stricken with a solid line through the center. Words and figures added by the amendment are underlined with solid lines. The codifier is instructed to omit the words and figures deleted and the solid underlining inserted when codifying this ordinance.

SECTION V. The effective date of this ordinance shall be after second reading of this ordinance.
