**AN ORDINANCE OF THE CITY OF WINCHESTER, KENTUCKY AMENDING THE
WINCHESTER CODE OF ORDINANCES, CHAPTER 11 TO ADD SECTION 11-19,
REQUIREMENTS FOR REPOSSESSION OF MOTOR VEHICLE S WITHIN CITY
LIMITS**

WHEREAS, The City of Winchester desires to provide public safety, and administrative guidelines for the lawful recovery of vehicles as permitted to repossession service companies that conduct business in the City of Winchester

NOW, THEREFORE, be it ordained by the City of Winchester as follows:

Section I. That Section 11 of the Code of Ordinances of the City of Winchester, Kentucky be and is hereby amended to read in full as follows:

**11-19 (reserved). Requirements for Repossession of Motor Vehicles within
City limits**

(a) Repossession agents, workers, drivers, employees, secured parties, lien
holders, and title holders that for the purposes of recovery of a motor vehicle
shall notify the police department prior to attempting the recovery.
(1) The recovery party shall notify the Police Department of: location of the
recovery, vehicle information, and title holder information.
(2) The recovery shall not breach the peace as defined KRS 355.9-609
(3) Recovery Services shall obtain a city business license.

SECTION II. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

SECTION III. All portions of this Ordinance amending the Code designate words and figures, which are deleted by including such words and figures stricken with dashed lines through the center. Words and figures added by the amendment are underlined with solid lines. The codifier is instructed to omit the words and figures deleted and the solid underlining when codifying this Ordinance.

Introduced and given first reading at a meeting of the Board of Commissioners of the City of Winchester, Kentucky held on February 16, 2016 and finally adopted, after second reading at a meeting of the said Board held on March 1, 2016 .
